Briefing Note ISO/IEC 27006-1:2024

At its General Assembly (March 2024) the International Accreditation Forum (IAF) agreed that the **transition period** for this new standard would be **2 years from the date of publication**. The date of publication was in March 2024.

This means that ISO/IEC 27001:2022 with ISO/IEC 27006:2015/Amd 1:2020 Requirements certificates **expiry date is 31 March 2026**.

IAF MD 29:2024:

As requirements for audit time determination have changed in the 2024 edition of ISO/IEC 27006-1, it is possible that the contract between the CAB and their existing certified clients may need to be revised.

Before any audits to ISO/IEC 27001:2022 with ISO/IEC 27006-1:2024 requirements take place the **auditor training and competence** approval need to be finalised.

Timeline for ISO/IEC 27006-1:2024:

Please note that ISO/IEC 27006-1:2024 was published in March 2024. With this release, ISO/IEC 27006:2015/AMD 1:2020 will be withdrawn. Companies certified to the ISO/IEC 27006:2015/AMD 1:2020 standard requirements now have a Two-year period to Transition their certificate to ISO/IEC 27006-1:2024 requirements. We recommend that your preparations start now. Kindly go through the requirement and follow with the following plan:

1. Validity of any ISO/IEC 27001:2022 with requirements of ISO/IEC 27006:2015/Amd 1:2020 Certificate shall be restricted to: 31 March 2026.
2. All the existing client need to submit the Transition plan by 31 December 2025.
3. Transition can be done either in surveillance audit or separate audit.
4. No certificate of ISO/IEC 27001:2022 with ISO/IEC 27006:2015/Amd 1:2020 requirements shall be issued after 31 December 2025.
5. Transition to all ISO/IEC 27001:2022 with requirements of ISO/IEC 27006:2015/Amd 1:2020 to ISO/IEC 27001:2022 with requirements of ISO/IEC 27006-1:2024 shall be started by 01 January 2025.
6. Timeline to ISO/IEC 27001:2022 with requirements of ISO/IEC 27006-1:2024 needs to be done for all clients by December 31, 2025.
